

## *For international students*

2008–2009

The student body of Bob Jones University includes students from many countries around the world, and we are pleased with the contributions our international students have made on the campus. The enrollment of an international student (including the evaluation of his transcripts, assistance toward securing his visa, and so forth) is a big undertaking, and we find that it takes international students at least a year to become adjusted and to begin to receive the fullest benefit from their training. We, therefore, prefer not to enroll an international student who does not intend to complete his degree at Bob Jones University.

U.S. universities are required by law to verify that students entering the United States with temporary student visas have adequate financial resources to meet the expenses of their program of study. You must satisfactorily complete this form in order to receive a Form I-20 from Bob Jones University, which you will use to apply for your student visa. All signatures and documentation provided must be originals and should be less than one year old. Be sure to include complete documentation for your source of funding.

\*If you are bringing more than one child, add an additional \$4,391 for each child.

There are two plans by which an international student may make financial arrangements to attend BJU.

### **Method I**

The student will need to complete page 3 (Financial Affidavit) and will need to provide one (1) original letter in English (or with an English translation) on official bank stationery from a bank or other financial institution showing that the student possesses the finances to cover all expenses. The specific amount of funds verified must total at least U.S. \$21,867, and the figure must be in U.S. dollars (if there are additional family members coming with the student, please refer to the chart above for the proper amount). Before the student can be accepted, he must pay in advance the entire cost of room, board, tuition and fees for one year, which amounts to U.S. \$16,830. If the student is expelled, requested by BJU to withdraw, or withdraws voluntarily, he will be refunded the unused portion of his advance payment.

### **Method II**

The student must secure a guarantor who will certify in writing to BJU that he will assume full financial responsibility for the student for at least one full year. Any of the suggested methods of payment for American students may be used. This information is outlined in the University Catalog. The total amount for room, board, tuition, fees and living expenses for one full year is U.S. \$21,867 (if there are additional family members coming with the student, please refer to the chart above for the proper amount). If the student is expelled, requested by BJU to withdraw, or withdraws voluntarily, the guarantor will be responsible for all fees and a prorated amount of room, board and tuition.

BJU will accept the following statement (Guarantor Form) signed by a United States citizen residing in the United States and acceptable to Bob Jones University to act as guarantor.

**If the student chooses Method II, the guarantor must complete page 2 (Guarantor Form) in full, and the applicant must complete page 3 (Financial Affidavit) of the form.**

4. If the applicant is accepted by Bob Jones University, I guarantee all expenses for room, board, tuition and fees as outlined in the Bob Jones University catalog.
5. I guarantee that the student will not become a financial liability to the United States government.
6. Unless I notify BJU otherwise, I agree to assume the responsibilities for room, board, tuition and fees for each year the student is enrolled until the termination of his enrollment.

The guarantor must include with this form one (1) original letter on official bank stationery from a bank or other financial institution in which the sponsor has savings deposits, certificates of deposits, money market certificates or other types of accounts containing readily available funds. The letter must provide a specific amount of funds that the guarantor has available. If funds are in more than one financial institution, separate letters must be submitted from each.
